## VILLAGE BOARD MEETING – OCTOBER 24, 2013

Mayor Reynolds called the meeting to order at 7:00 p.m. with the Pledge of Allegiance. Also present were Deputy Mayor Lockhart, Trustees VanDeusen, Suitor and Adamson. Attorney Caserta, DPW Superintendent Muller, Building Inspector Stevens, Engineer Lannon, and several interested residents.

Mayor Reynolds then asked for Public Comment. Mr. Mike Fox and Mr. Aaron Dey then gave a brief presentation in support of holding a fund raiser next summer to support the ALEXA FOUNDATION. Mr. Dey then went on to explain this is a worthy charity based in Lewiston, NY that was established in 2003. The purpose of the Foundation is to help/support rape survivors through the trauma of the criminal trial, in hopes that more survivors will go through with the prosecution in order to put perpetrators behind bars. The Foundation assists rape victims and their families with support, guidance and travel expenses during the litigation process. The fund raiser or "The Great Contraption Race" will be held Saturday, August 2, 2013 starting at 9:00 a.m. and finishing at Falkner Park with food, drinks and music. Mayor Reynolds and the Board gave approval for the use of Falkner Park and thanked Mr. Dey and Mr. Fox for their presentation. With no further public comment, the meeting continued.

Building Inspector Stevens informed the Board that the storm water report had been finished and mailed. Also, the Hastings property on Main Street is moving along with clean-up when weather permitting.

Police Chief Salada was absent.

DPW Superintendent stated that tree trimming continues and leaf pick-up has started and the guardrail on Main Street has been put back up. Trustee Adamson asked Superintendent Muller if he has looked into energy efficient lights for the Board Room and also suggested that he check with NYSERDA for any offers they might have to help with the costs. Superintendent Muller stated he will check into it.

Engineer Lannon stated that he really does not have anything at this time. Deputy Mayor Lockhart then asked Engineer Lannon if he would come up with a design and estimate for a walk-way for the southern part of Water Street. Deputy Mayor Lockhart also asked for Engineer Lannon's opinion and estimate on water line repairs/replacement on Lockport Street and also to disconnect the water line that goes to the water tower. Engineer Lannon will prepare these reports for the next Board Meeting.

Attorney Caserta asked for a motion for Mayor Reynolds to sign the contract for the appraisal of the vacant property located at 347 Main Street. Motion to approve made by Trustee Suitor and seconded by Trustee Van Deusen.

<u>REPORTS</u> – Trustee Van Deusen gave an update on the RRG meeting she attended and the passing of the bill to halt Waste Management was tabled for now and will go to the committee. Trustee Van Deusen then stated that it is very important that the people call their Legislator and stress how important it is to have them pass this bill.

Trustee Adamson stated that he attended the Homeland Security Forum and two important issues were discussed – that an Emergency/Disaster Plan be drawn up and also a plan concerning what to do with pets in the event of an emergency. Trustee Adamson also stated that the Historical Society will be taking applications for the update on the Veterans Memorial until November 11, 2013, and asked everyone to spread the word so no one is left out.

Trustee Suitor stated that he continues to work with Dottie Riordan on the Veterans updates. He also asked Attorney Caserta to draft a copy of the hunting code and to update/change it to address hunting on private property.

Mayor Reynolds then asked if the public had any issues to discuss or comment – with no response the Mayor then stated the Board will be entering into executive session. Motion to close the Village Board Meeting and enter into executive session was made by Trustee Adamson, seconded by Trustee Suitor and carried. Village Board Meeting ended at 8:15 p.m.
