Bushes, shrubs and hedges shall be trimmed regularly during the growing season so as to avoid an unsightly appearance. Lawns shall be maintained to a height no greater than 6". Properties not in compliance will face enforcement action as outlined in this chapter, with costs incurred by the Village to be added to and become part of the taxes.

The area of properties that are not in compliance must be maintained to the same area prior to the noncompliance of the property.
