Village of Youngstown Board of Trustees Minutes– June 27, 2023

PRESENT: Mayor Reisman, Trustee Quarantillo, Trustee Stevens, Attorney Caserta, Clerk-Treasurer Brown. **ABSENT:** Deputy Mayor Heath, Trustee Stella.

CALL TO ORDER: Mayor Reisman called the meeting or order at 6:00 p.m. with the Pledge of Allegiance. Mayor Reisman then opened the public hearing by reading the notice below.

PUBLIC HEARING:

NOTICE IS HEREBY GIVEN that the Board of Trustees of the Village of Youngstown, 240 Lockport Street, Youngstown, NY, will hold Public Hearing on Tuesday June 27, 2023 at 6:00 p.m. in the Board room for the purpose of hearing all interested parties concerning a rate increase for Sewer rates. This is a pass-through increase from the Town of Porter. Sewer rates will increase from \$6.58/thousand gallons to \$7.03/thousand gallons.

Mayor Reisman asked for any public comment:

PUBLIC COMMENT-PUBLIC HEARING-all comments shall be kept to 3 minutes and directed to the Village Board of Trustees.

Heidi Reisman of Glenvale Dr asked Mayor Reisman to repeat the new rates. Mayor Reisman stated the rates. With no further public comment, Mayor Reisman asked the Board if there was any discussion on the rates.

DISCUSSION: The Board had no questions and did not have further discussion.

CLOSE PUBLIC HEARING:

With no further action, motion was made at 6:03 p.m. to close the public hearing by Trustee Quarantillo, seconded by Trustee Stevens. All in favor, motion was carried.

ACTION of the Board from the Public Hearing:

Motion to change the sewer rate from \$6.58/thousand gallons to \$7.03/thousand gallons was made by Trustee Stevens, seconded by Trustee Quarantillo. All in favor, motion was carried.

ITEM:

Request for the Clerk-Treasurer to make appropriation adjustments for water and sewer as per information presented to the Board for fiscal year ending May 31, 2023.

Motion to approve the appropriations was made by Trustee Quarantillo, seconded by Trustee Stevens. All in favor, motion was carried.

Request for the Clerk-Treasurer to make budget amendments for fiscal year ending May 31, 2023 in the general fund to adjust for AARPA funds (\$11,812.96) and Archives funds (\$8,094.48) in conjunction with the Village auditor.

Motion to approve the budget adjustments was made by Trustee Quarantillo, seconded by Trustee Stevens. All in favor, motion was carried.

With no further business, motion to adjourn the meeting was made at 6:10 p.m. by Trustee Quarantillo, seconded by Trustee Stevens. All in favor, motion was carried.
