The Clerks Office sent out their 3rd Quarter water billing the beginning of October. There was a total of 801 water bills sent out this quarter.

Treasurer's Report

October 31, 2024 was the final day for paying taxes in the Village. The Village has an unpaid taxes of \$ 21,701.40. This was sent to the County of Niagara, who will reimburse the Village for the whole amount. We believe we will see this money in March 2025.

The monthly financials are current through the end of October 2024 and every effort will be made to reconcile each month within 10 days so that any budget concerns can be addressed in a timely manner.
